Annual Meeting

The Annual Meeting of the
Membership is scheduled for:

**Thursday
November 15, 2007
7:00PM.
At the Ramada Inn**

As you may recall, last year the
California State Assembly changed the
voting regulations on how members
are elected to the Board of Directors
in homeowner associations.

The first change is that a nomination
form will be mailed to the entire
membership. Those members who
wish to be considered for a position
on the Board must fill out the form
and return it in the required
timeframe. Members can choose to
submit their own one page bio, but at
a minimum, this nomination form
must be filled out in order to have a
members name placed on the secret
ballot.

Once the candidates have been
determined by the nomination forms,
the secret ballot is created using the
names submitted. A copy of the bio
or a summary of the Nomination
Forms is included in the annual
meeting package so that homeowners
can review the statements from the
various candidates.

Additionally, this annual meeting
package will contain a secret ballot,
yellow outer envelope with a proxy

label and a smaller white secret ballot
envelope. Once you have marked
your ballot, you are instructed to
place the secret ballot in the white
envelope, seal the white envelope and
place it in the prepaid yellow outer
envelope. You are then instructed to
seal the yellow outer envelope, and
put your address and signature on the
proxy label in the upper left hand
corner so that we can verify the vote.

The ballots are brought to the annual
meeting where the Inspector of
Elections opens and counts the
ballots. The totals are given to the
Board and the election results are
announced at the meeting.
